

Privacy Policy

Policy on the personal data processing

1. General Provisions

This personal data processing policy is drawn in accordance with the requirements of the Federal Law “On Personal Data” of 27.07.2006 No. 152-FZ, and defines the procedure for personal data processing and measures to ensure the safety of personal data by the Hibla Gerzmava International Charitable Foundation (hereinafter the “Operator”).

The Operator’s main goal and condition for carrying out its activities is to respect the rights and freedoms of individuals and citizens when processing their personal data, including protecting the rights to privacy, personal and family secrets.

This Operator’s personal data processing policy (hereinafter referred to as “the Policy”) applies to all information that the Operator may obtain about visitors of the following website: www.competitionhibla.ru.

2. Main definitions used in this Policy

Automated personal data processing is processing of personal data with the use of computers;

Blocking of personal data is temporary termination of processing of personal data (except for cases when processing is necessary to clarify personal data);

Cross-border transfer of personal data is the transfer of personal data to the territory of a foreign state to a foreign state authority, a foreign individual or a foreign legal entity;

Destruction of personal data means any action resulting in the destruction of personal data irretrievably making it impossible to restore the personal data content in the information system of personal data and (or) resulting in the destruction of tangible media of personal data;

Dissemination of personal data means any actions aimed at disclosure of personal data to an indefinite group of persons (transfer of personal data) or at making personal data available to an unlimited number of persons, including

publication of personal data in mass media, placement in information and telecommunication networks or providing access to personal data in any other ways;

Information system of personal data is an aggregate of personal data contained in databases of personal data and information technologies and technical means ensuring processing thereof; Operator is a state body, a municipal authority, a legal entity or an individual, independently or jointly with other persons, arranging and (or) carrying out processing of personal data, as well as determining the purpose of personal data processing, composition of personal data to be processed, actions (operations) performed with personal data;

Personal Data is any information relating directly or indirectly to an identified or identifiable User of the www.competitionhibla.ru website;

Personal data depersonalisation means actions, as a result of which it is impossible to determine without use of additional information whether personal data belongs to a certain User or other subject of personal data;

Processing of personal data is any action (operation) or a series of actions (operations), performed with or without the use of automation means, with personal data, including collection, recording, systematization, accumulation, storage, clarification (updating, change), extraction, use, transfer (distribution, provision, access), depersonalisation, blocking, removal, destruction of personal data;

Provision of personal data means actions aimed at disclosure of personal data to a certain person or a certain group of persons;

User is any visitor to the website www.competitionhibla.ru;

Website is an aggregate of graphic and information materials as well as computer programs and databases making them available on the Internet at the address www.competitionhibla.ru.

3. The Operator may process the following personal data of the User:

- Surname, first name, patronymic;
- E-mail address;
- Phone numbers;
- Year, month, date and place of birth;
- Brief information about the participant;

- The website also collects and processes depersonalised visitor data (including cookies) using Internet statistical services (Yandex Metrics, Google Analytics, and others);
- The above-mentioned data are hereinafter referred to under the general term “Personal Data” in this Policy.

4. Purposes of personal data processing

The purpose of processing of the User’s personal data is to accept applications for participation in the Competition.

The Operator also has the right to send notifications about new products and services, special offers and various events to the Users. The User can always refuse to receive information messages by sending an email to the Operator at info@fondpetrov.ru with the note “Cancel notifications about new products and services and special offers”.

The depersonalised User data collected through the Internet statistics services are used to collect information about the User’s activities on the website and to improve the quality of the website operation and its content.

5. Legal basis for personal data processing

The Operator processes the User’s personal data only if the User fills in and/or submits the data themselves via the special forms available on the website www.competitionhibla.ru. By filling in the relevant forms and/or sending their personal data to the Operator, the User expresses their consent to this Policy.

The Operator processes depersonalised data about the User in case it is permitted in the User’s browser settings (cookie saving and the use of JavaScript technology are enabled).

6. Procedure for collection, storage, transfer, and other types of personal data processing

Safety of personal data, which the Operator processes, is ensured by implementing legal, organisational and technical measures, necessary for meeting in full the requirements of applicable legislation in the sphere of personal data protection.

The Operator provides safety of personal data and undertakes all possible measures, which prevent unauthorised persons from access to personal data.

The User’s personal data shall never, under any circumstances, be disclosed to third parties, except in cases related to the enforcement of applicable laws.

In case of any inaccuracies in the personal data, the User may update the personal data themselves by sending a notification to the Operator’s email address info@competitionhibla.ru, marked “Personal data update”.

The period of personal data processing is unlimited. The User may withdraw their consent to the personal data processing at any time by notifying the Operator via email at info@fondpetrov.ru, marked with “Withdrawal of consent to the personal data processing”.

7. Cross-border transfer of personal data

Before the cross-border transfer of personal data, the Operator undertakes to ensure that the other country, to the territory of which the personal data transfer is intended, provides adequate protection of personal data subjects’ rights.

Cross-border transfer of personal data to other countries that do not meet the aforementioned requirements may take place only if the personal data subject consents in writing to the cross-border transfer of their personal data and/or execution of an agreement to which the personal data subject is a party.

8. Final provisions

The User can obtain any clarification on the questions of interest relating to their personal data processing by contacting the Operator by email at info@competitionhibla.ru.

This document will reflect any changes to the Operator’s personal data processing policy. The Policy is valid indefinitely until it is replaced by a new version.
